# 16 to 18 Revised Data

### **Publication details**

Revised 2024 16 to 18 performance data is due to be published at **9:30am** on **Thursday 13 February 2025 here**.

The 'Compare school and college performance data in England' service will contain data based on the results of students at the end of 16 to 18 studies in the 2023/24 academic year.

#### Early access to publication data

You can view your revised data, in advance of publication here.

### This information is being provided to you in advance, in confidence and on the condition that it is not released to other persons outside of your school or college before 9:30am on Thursday 13 February 2025.

This data reflects:

- Add student requests, student removals and merge student requests accepted during the 2024 16 to 18 Autumn Checking Exercise.
- Late results/re-marks for your school or college received up to 1 November 2024 for students already triggered for inclusion.

You can also access the 16 to 18 CSV file guidance on the **CYPMD Help Centre** which will help you interpret your school or college data.

Any grade changes/re-marks received after this date for students already allocated to your school or college will be included in final data published here later this year.

# **Newly Triggered Students**

Your school or college's results CSV file on the CYPMD portal will now include previously missing qualifications. These additional results may have introduced new students into your data or may cause previously untriggered students to become triggered and therefore included in performance measures calculations.

As your school or college did not have the opportunity to remove these students during the 2024 16 to 18 Autumn checking exercise, you can now request the removal of these students.

Your school or college must request any student removals before 5:00pm on Friday 14 February. After this date the facility to do this will be removed from the CYPMD portal.

Please refer to page 15 of the **2024 16 to 18 Autumn Checking Exercise Guidance** to check the student removal request categories and information/evidence requirements that you will need to provide to support your request. You can also refer to the **2024 16 to 18 Autumn Checking Exercise 'How to' guidance** which explains how to request and submit a student removal.

# Your school or college will not be able to request the removal of any other students.

Decisions for student removal requests raised during the 16 to 18 Revised Data Checking Exercise will be shared with schools and colleges at a later date. Any accepted student removals will be reflected in **final** data when published later this year.

### Results

Result enquiries received during the Autumn checking exercise have been reviewed and we have shared details of missing/incorrect grades with Awarding Organisations (AOs).

AOs have until Wednesday 12 February 2025 to provide us with any outstanding late results/re-marks. Any further late results/re-marks received by this date for students already triggered for inclusion will be reflected in final data to be published later this year.

# Value Added

In November 2024 we were unable to share value added data for the Applied General and Tech Level cohorts. A revised value added CSV file is now available **here**, which includes A level, Academic, Applied General and Tech Level cohorts.

In addition, it was found that prior attainment scores used to calculate value added scores had not included double award Science GCSEs which has also been fixed in the revised value added data.
