2025 Key Stage 2 (KS2) September Checking Exercise

The 2025 Key Stage 2 September Checking Exercise will **open on Monday 8 September 2025 and close at 5:00pm on Friday 19 September 2025**.

Changes Since 2024

There have been some changes to the 2025 KS2 September checking exercise:

- the KS2 September CSV files have been improved to help you interpret your school data
- the 'Child missing education' pupil removal category has been updated to reflect current legislation
- the process for submitting your school's 'full return summary' on the CYPMD portal has changed. There are now prompts and clearer wording within the CYPMD portal to provide further clarity on when and how a 'full return summary' should be submitted, if applicable. Schools will also receive an email confirmation when the 'full return summary' has been completed. Please refer to the 'How to' guide or the video walkthroughs for step-by-step instructions which will be made available on the CYPMD Help Centre prior to the checking exercise opening.

To assist schools with their participation in the 2025 KS2 September checking exercise we shared the **2024 KS2 September Checking Exercise Requests Summary** in April. This summarises the requests submitted during the 2024 KS2 September Checking Exercise, alongside common reasons why some amendment requests could not be accepted.

CYPMD Portal
